As such, we are seeking for your **immediate** support by cancelling the membership of **all of Russian organizations** in the International Bridge, Tunnel & Turnpike Association. Such action from your organization will send a clear message that the actions of Russia are unacceptable to the world community in the 21st century. We consider this to be an appropriate and proactive response to Russia's aggressive actions, since they are using roads for transporting military into Ukraine for the purpose of war.
